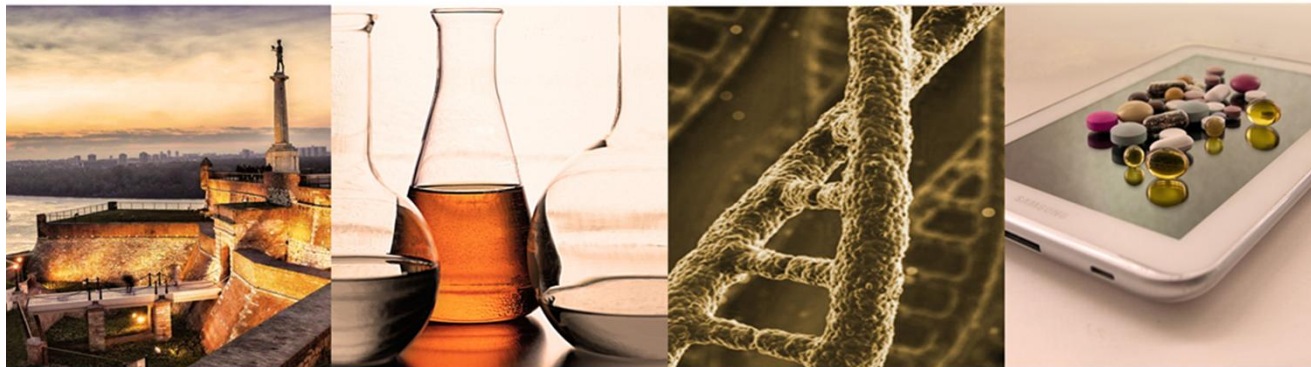

Dear colleagues,



3. Abstracts should include introduction, objectives, materials and methods, results and conclusion (without relevant subtitles). Tables, figures and references should not be included.
4. Abstracts should be submitted using the online application form available at:

5. Please indicate the section and preferred presentation format (oral or poster presentation).

Deadline for abstract submission is June 15, 2018.

Notification of abstract acceptance will be sent by e-mail to the presenting author by July 31, 2018. Accepted abstracts will be published in the special issue of the *Archives of Pharmacy* (please note that presenting authors should register and pay the registration fee before August 10, 2018).
